Ofsted launches new social care common inspection framework (22/02/17)

A range of children's social care settings will be subject to the same SCCIF from 1 April 2017, Ofsted has announced.

Last year Ofsted published a consultation on the principles for children's social care inspections, with a new common inspection framework and proposals for a new approach to the inspection of LA children's services.

From 1 April, the following 3 principles will link all our inspections of children's social care providers:

- to focus on the things that matter most to children's lives
- to be consistent in our expectations of providers
- to prioritise our work where improvement is needed most

In January 2015, Ofsted announced its intention to carry out a study of the reliability of short inspections after they were introduced in September 2015. This was in response to criticism that Ofsted had not done enough in the past to reassure heads and teachers that school inspection judgements were consistent and reliable.

This study was designed to be a first step in collecting evidence on the reliability of inspections. Major new drive on internet safety (27/02/17)

Ministers have begun work on a new Internet Safety Strategy aimed at making Britain the safest country in the world for children and young people to be online. Culture Secretary Karen Bradley is leading the new cross-Government drive on behalf of the PM – with a green paper expected in the summer.

A report has been commissioned to provide up to date evidence of how young people are using the internet, the dangers they face, and the gaps that exist in keeping them safe.

Ministers will also hold a series of round tables in the coming weeks with social media companies, technology firms, young people, charities and mental health experts to examine online risks and how to tackle them.

The work is expected to centre on:

- how to help young people help themselves:
- helping parents face up the dangers and discuss them with children:
- industry's responsibilities to society; and
- how technology can help provide solutions.

The focus will be on preventing children and young people from harm online and making the internet a safer place. The round tables are also expected to examine concerns around issues like trolling and other aggressive behaviour including rape threats against women.

High demand requires exceptional collaboration between LAs and Cafcass (February 2017)

ADCS and Cafcass have agreed how social workers in both LAs and those acting as guardians in family proceedings can better work together during care proceedings and pre-proceedings in the family courts.

The agreement, launched on 10th February, confirms a 'culture of urgency' for children and young people. It acknowledges the pressure on the care system and sets out how LAs and Cafcass aim to work together to secure swift outcomes for children, young people and their families. It also recognises the distinct role social workers and guardians play and provides a framework for resolving disputes between professionals.

The agreement applies to both care proceedings and work to divert cases away from court, where this is the right thing to do for a child.

PM's plans to transform the way we tackle domestic violence and abuse (17/02/17)

Theresa May has announced plans to transform the way we think about and tackle domestic violence and abuse – one of the most widespread and heinous offences, but one where victims are often let down by the legal system.

Domestic violence and abuse shatters lives but the way we deal with it at the moment does not go far enough — with a plethora of different offences and procedures scattered across the statute book.

This lack of clarity has led to an unacceptable diversity across the country in terms of the degree of effort put in to try and tackle it. Although the prosecution of, and convictions for, such offences have started to improve in recent years, there is inconsistency in the use and effectiveness of the various law enforcement measures across the country.

In recognition of this, the Prime Minister has announced plans for a major new programme of work leading towards bringing forward a Domestic Violence and Abuse Act.

■ There were 18,990 CIN included in the CIN Census at 31/03/16 - a rate of 302 per 10,000 children aged under 18 years, and 105 who were unborn.

- 38% of referrals were from LAs and 34% from police and primary or community health services.
- 20% of CIN had a disability.
- Parental substance or alcohol misuse, domestic abuse and parental mental ill health capacity factors were each recorded for about a quarter of CIN.
- The attainment of CIN at each Key Stage assessment was much lower than the average for all pupils.

NICE guidelines aim to improve how children at risk of abuse or neglect are helped and supported (22/02/17)

NICE is producing new guidelines to help people who work with children spot and stop abuse or neglect. It outlines how social workers, teachers and police officers, along with others working outside healthcare, can spot the signs of abuse or neglect and how they should act faced with a range of differing circumstances.

The guidelines includes physical, mental and CSA as well as FGM, CSE, child trafficking and forced marriage.

It outlines soft signs that in themselves do not indicate abuse but warrant further consideration and harder warning signs that professionals should investigate.

The draft is available for public comment in a consultation.

Often cases of child abuse or neglect will go unreported because children feel ashamed or do not fully understand the wrongdoing. Therefore it is difficult to know exactly how many children are suffering.

NICE seeks to support new mothers with mental health problems
Some symptoms of mental health problems, such as changes to appetite or sleeping patterns, can be masked by what is considered normal for pregnant and postnatal women.

NICE suggest that the routine six-week postnatal appointment could provide an opportunity for new mothers to be asked about their mental health.

A £215m funding boost to transform the lives of thousands of children with special educational needs and disabilities, by increasing school capacity and making it easier for them to access good school places, has been announced by Edward Timpson, Minister for Vulnerable Children and Families.

Every local council's allocation is at least £500,000 to enable them to expand and improve their special educational needs and disabilities provision, with more than half receiving at least £1m.

Care of unaccompanied and trafficked children (03/03/17)

Since Summer 2016, the DfE has consulted and collaborated with a range of LAs, NGOs and other government departments to identify the required revisions and produce a revised draft of the 2014 statutory guidance on the care of unaccompanied asylum seeking and trafficked children.

This consultation now seeks views as to whether the revised guidance provides sufficient advice to LAs in England looking after unaccompanied migrant children and child victims of modern slavery.

The statutory guidance on the care of unaccompanied asylum seeking and trafficked children was originally published in 2014. Recent legislative changes such as the Modern Slavery Act 2015, policy developments such as the National Transfer Sche for unaccompanied asylum seeking children and events around the recent migration crisis have meant that it is necessary to update the guidance so that it is of best use to local authorities.

It covers physical, sexual and emotional abuse, neglect, and some particular safeguarding issues including CSE, child trafficking and forced marriage. It aims to help all practitioners working with children and young people to recognise abuse and neglect, carry out an assessment and provide early help and interventions to children, young people, parents and carers.

NICE has also produced a guideline on child maltreatment covering clinical features of maltreatment. 'Maltreatment' covers both abuse and neglect.

Allowing schools to hold spare adrenaline auto-injectors (10/03/17)

This consultation seeks views on whether legislation should be changed to allow schools to choose to hold spare adrenaline auto-injectors (AAIs) for use in emergencies.

Currently, AAIs are prescription only medicines, which means that schools cannot keep spares for use in emergencies. Following the recommendation of the Commission on Human Medicines, the government is proposing to change the Human Medicines Regulations 2012 to enable schools to purchase and hold spare AAIs for use in emergencies.
