# Private Tuition and Supplementary Schools

**This leaflet is to help you choose the right tutor for your child; if this is something you think would be of benefit.**

Local authorities and schools do not hold lists of private tutors or supplementary schools. Parents and carers wishing to supplement or replace state-funded education are solely responsible for arranging and funding this. Local authorities will not recommend any particular tutor or supplementary school. This leaflet is designed only to provide some information about tutors and supplementary schools.

## Private tutors

Tutors can work independently or for a tuition company. A good tutor can help a child improve their exam grades, learn an instrument or provide coaching in activities such as sport, dance and drama. They are not required to register with, or be approved, by any statutory organisation.

It is important that parents check tutors are suitably qualified in their subject and cleared to work with children and young

people. Recommendations from other parents are a good way of finding a tutor. Your child's school may offer additional support, or advice on extra tuition available and will have a good idea of your child's needs. It is your responsibility in choosing an appropriate person as a tutor for your child.

Always interview any candidates and check their references and qualifications.

## Keep your child safe

**Make sure you are hiring someone who is qualified and suitable to work with children:**

- Where possible, ask your child's school for advice first. If you choose not to, you should still inform the school of your intention to provide additional tutoring.
- Ask for written references from the tutor, or their employer, and call the referee to confirm them.

- Ask to see qualifications (originals, not copies) and ask for explanations for any gaps or career breaks.
- Ask to see evidence of a current Disclosure and Barring Service check, dated within the last 3 years. This will show they are cleared to work with children and vulnerable people. Self-employed tutors can get a Police Disclosure from their local police station instead.
- Arrange for the tutor and your child to have a supervised meeting before hiring them. This should help you decide if they are the right tutor for your child.
- When tutoring takes place in your home, provide an organised and quiet

study area that is free from distractions and enables you to observe lessons. Never use a bedroom. Wherever tutoring takes place, make sure you are on the premises during the lesson.

- Talk to your child about their progress and see their written work. Ask them about their lessons and, when your child has group tuition, check that they remained in the group.

Any adult or child who behaves in an inappropriate or abusive manner with a child or vulnerable adult should be reported to Social Services or the police. If your child tells you about any inappropriate behaviour, [report it](#), reassure them that it is not their fault and stop lessons immediately.

## Supplementary Schools

Supplementary schools are community-led organisations which usually operate at weekends, offering one or more of the following for a few hours each week:

1. Skills in maths and English
2. Home language and heritage studies
3. Cultural activities and religious studies

A well run supplementary school can make a significant contribution to a child's self-esteem and well-being. You should **always** ask for their safeguarding policy and check the organisation out thoroughly. Many seek the nationally recognised form of accreditation called the Quality Framework for Supplementary Schools delivered by the [NRCSE](#).

**A provider is not allowed to operate as a school offering a full curriculum without being registered with OFSTED.**

If a tutor or supplementary school is not willing to allow you to make reasonable checks or to answer reasonable questions

about themselves or their staff, it is recommended that you **do not** use their services.

Reporting your concerns about safeguarding matters to the **Golden Number** will enable them to be investigated and help protect your child and others.
