### Home Secretary launches Serious Violence Strategy (09/04/18)

Amber Rudd set out a multi-million pound commitment to steering young people away from crime and tackling violent drug-dealing gangs.

Commissioned by the Home Secretary and backed with £40m of HO funding, the government's first Serious Violence Strategy marks a major shift in the government's response to knife crime and gun crime.

It strikes a balance between prevention and robust law enforcement with a new £11m Early Intervention Youth Fund for community projects to help young people live lives free from violence.

The strategy identifies the changing drugs market – in particular the devastating impact of crack cocaine – as a key driver of the violence harming our communities and announces a range of powerful actions to tackle the issue of 'county lines' and its implications for drugs, violence and exploitation of vulnerable people. That includes £3.6m to establish a new National County Lines Co-ordination Centre.

The Home Secretary will launch the Serious Violence Strategy at an event in London today to an audience of community groups, public sector partners and industry representatives, including organisations and charities she has met in recent weeks.

She will also announce that she will lead a new Serious Violence Taskforce which will bring together the voluntary sector, local government, police and other key sectors to ensure the strategy is delivered effectively.

In the most successful examples, schools overcome potential barriers to managing the transfer of a pupil from one school to another by involving all parties in carefully planning the move.

Estyn's report examines the transfer of pupils who may have emotional and behavioural difficulties and are at risk of permanent exclusion, pose a risk to the welfare of others, or refuse to attend school. ## New action to improve outcomes for children with additional needs (16/03/18)

Steps to transform education for children with additional needs and plans to improve the experiences of children in alternative provision have been announced by the Education Secretary.

Evidence shows children educated in alternative provision are less likely to achieve good GCSE grades and are less likely to be in education, employment or training post-16. Previous analysis also shows that children excluded from school are more likely to end up in the criminal justice system.

The plans aim to tackle those inequalities and ensure Britain is a country that truly works for everyone by looking at the experience and outcomes for children who face the most challenges in mainstream school - including those at greatest risk of exclusion - such as those with SEN, children with autism or children in need of help and protection, including those in care.

They include an externally led review of school exclusions which will look at why some children are more likely to be excluded than others. ### New alliance to boost confidence in reporting child abuse (15/03/18)

A new phase in a campaign to tackle child abuse and neglect has been launched, as new research reveals the extent of public confidence in reporting child abuse or neglect.

According to new analysis from YouGov, 26% of adults surveyed said they had worried about the welfare, neglect or abuse of a child, of which 42% did not report their suspicions to someone with child protection responsibilities.

The campaign is being delivered with the support of the LGA and many participating local councils, as well as police forces, community organisations and the voluntary sector across the country.

Among parents of under 16s questioned by YouGov, 31% had worried about a child's welfare, or about abuse or neglect of a child in their local area, but 57% went on to take any action to raise their concerns.

Overall, 24% of those parents who had concerns and took action had tackled the situation directly, 69% had sought advice and 16% had reported their concerns to a professional, suggesting there is more to be done to help build public confidence in knowing when and how to report a case of suspected abuse.

## Are we listening? A review of children and young people's mental health services (12/03/18)

The PM asked the CQC to conduct a review of quality and access across the system of mental health services for children and young people. This report marks the second phase of that review.

The report draws on evidence gathered from fieldwork in 10 health and wellbeing board areas in England.

We looked at three main aspects of the mental health system for children and young people:

- People's experience of and involvement in care
- How partners plan and deliver services that offer high quality care that can be accessed in a timely fashion
- How partners in the local area identify mental health needs and what they do to start the process of getting the right support for children and young people

We found that many children and young people experiencing mental health problems don't get the kind of care they deserve. The system is complicated, with no easy or clear way to get help or support.

We saw examples of services with caring and dedicated individuals who put children and young people at the centre of what they do. But these people are often working long hours, with limited money and an increasing demand for their services to overcome barriers to providing high-quality care.

Things need to change at the top, so those working with children and young people have the support they need to be able to provide the best care.

We have made some recommendations to organisations responsible for making sure that the problems with mental health services are dealt with, including:

- The Secretary of State for Health and Social Care should make sure there is joint action across government to make children and young people's mental health a national priority, working with ministers in health, social care, education, housing and local government
- Local organisations must work together to deliver a clear 'local offer' of the care and support available to children and young people
- Government, employers and schools should make sure that everyone that works, volunteers or cares for children and young people are trained to encourage good mental health and offer basic mental health support
- Ofsted should look at what schools are doing to support children and young people's mental health when they inspect

### **Incentivising and promoting good behavior** (21/03/18)

HMI Prisons has published a new thematic report — based on a review focusing on children held in secure training centres and young offender institutions, and young adults aged 18–20 held in YOIs.

The review looked at the "fundamentally important issue of the relationships between those detained and the staff charged with their care."

Inspectors found that "far too often the rewards and sanctions associated with behaviour management schemes were focused on punishment rather than incentive, and were prone to generate perceptions of favouritism. Too often, during inspections, we have seen rewards and sanctions schemes that are overwhelmingly punitive, and the response to poor behaviour is to become locked in a negative cycle of ever greater restriction."

The review reached other conclusions:

- Time out of cell: A combination of staff shortages and increasing levels of bullying and violence had led to many young people spending long periods of time in their cells with little to occupy them. Young people and staff agreed more time out of cell would have the greatest impact on promoting positive behaviour.
- Interventions for young people who display the most difficult behaviour:
   The proportion of children and young people in custody who have been

convicted of more serious offences has increased. The report noted: "Too often we find institutions which accept poor behaviour as unavoidable instead of setting and maintaining high standards. However, there are now some young people within the estate who do not respond positively to existing behaviour management schemes and who require a higher level of support than is currently offered."

- Bullying and violence: Witnessing or experiencing bullying and violence are part of everyday life for young people in custody.
- Young people from a black or minority ethnic background: They were less likely to report being treated fairly by the rewards and sanctions scheme than white young people. "As young people from a black and minority ethnic background make up a large proportion of the population in custody it is important that the reasons for these perceptions are understood and addressed to improve behaviour". https://www.justiceinspectorates.gov.uk /hmiprisons/media/pressreleases/2018/03/children-and-youngpeople-in-custody-tackle-violence-andbullying-and-do-more-to-promotepositive-behaviour-says-chiefinspector/

## New figures show improved referrals to Prevent and a rise in far-right concerns (27/03/18)

Figures show that between April 2016 to March 2017, 6,093 individuals were referred to the government's Prevent programme and of those who received support from Channel, over a third were as a result of far-right concerns.

The figures also show:

- of those referred to Prevent, 332 individuals went onto receive support from Channel as well as 54% of all referrals being signposted to other forms of support
- the proportion of individuals supported by Channel as a result of far-right concerns has risen from a quarter in 2015 to 2016 to over a third in 2016 to 2017

### Children in need of help and protection: call for evidence (16/03/18)

We want to understand what it is that makes the difference to the educational outcomes of Children in Need in practice, how some Children in Need can achieve better educational outcomes than others, and what works in enabling Children in Need to achieve their potential.

We need to develop a stronger evidence base, going beyond the data to look at what is happening in practice. At different stages in a child's life, or when requiring different levels of statutory social care support, children's needs will require a different response. At each of these stages, a child may work with a variety of professionals who offer support to a child and to their family, to improve a child's circumstances.

Through the call for evidence, we want to understand how the work of professionals supporting Children in Need can make a difference to a child's educational outcomes. Specifically, we are interested in:

- how support is delivered or commissioned to help children
- how this support is measured and evaluated
- how this support influences educational outcomes

Children in Need are a legally defined group of children, assessed as needing help and protection as a result of risks to their development or health. This group includes children subject to Child in Need Plans, Child Protection plans, Looked After Children, young carers; and disabled children.

### **Exclusions review: call for evidence** (16/03/18)

The Ethnicity Facts and Figures website, which collates data on how different ethnic groups interact with public services, highlighted that pupils from some ethnic backgrounds are disproportionally more likely to be excluded from school. This review will explore how head teachers use exclusion in practice, and why some groups of pupils are more likely to be excluded.

All state funded schools in England operate under the same exclusions framework, as set out in legislation and statutory guidance. Despite this, there are differences in exclusion rates between schools, areas of the country, and pupils with different characteristics. This review will examine the factors that drive those differences. It will also explore and evaluate best practice for those areas where the disparities are less significant.

The review will consider the exclusion of groups of pupils identified in the national data as more likely to be excluded. For example, those ethnic groups highlighted in the Ethnicity Facts and Figures website; pupils who are eligible for FSMs or have been eligible for FSMs in the last 6 years; pupils with SEN; looked after children; and children in need.

Next steps for child mental health in England - developing a multi-agency approach and provision in schools 8th May 2018 London

8th May 2018 Londo £230 + VAT

This event brings together stakeholders and key policymakers to discuss priorities for improving children and young people's mental health provision.

It follows release of proposals in the green paper on children's mental health, including introduction of specialist mental health leads in schools and colleges, the creation of new community-based mental health support teams and the piloting of 4-week waiting times for services.

The seminar also takes place as the Education and Health and Social Care Select Committees launch a joint inquiry examining the scope and potential impact of the green paper, alongside the Science and Technology Committee inquiry into the impact of social media and screen-use on young people's health.

Delegates will discuss the potential challenges for implementing these key proposals - including funding concerns and the impact on teaching resources - as well as strategies for improving provision in the immediate term, and for developing a collaborative approach between schools, CAMHS and the voluntary sector.
