Responding to the New Children's Services Inspection Regime

Ofsted recently published the framework for its new inspection regime which will begin rolling out from January 2018. At its core, authorities will be required to evaluate themselves on the quality and impact of social work practice. This is so the gathered information can be used to tailor and prioritise inspections to each children's service.

Next steps for safeguarding children in England - implementing the Children and Social Work Act, strengthening multi-agency working and tackling CSA

Children and Young People's Mental Health: Providing Effective Support

3rd July 2018 London

Mental health issues are hitting the headlines more frequently than ever before, with children and young people being particularly vulnerable. Half of all mental health problems have been established by the age of 14, rising to 75% by age 24. While the national government has started implementing its Five-Year Forward View for Mental Health, with particular priority for children and young people, reports are not yet showing positive results.

A green paper was published in December 2017 on transforming mental health services for children and young people. There were several proposals, including:

- designating a senior mental health lead in schools,
- setting up a four-week waiting time for NHS CAMHS services,
- new mental health support teams in schools and
- all compulsory mental health awareness training.
