Members announced for new Child Safeguarding Practice Review Panel (07/06/18)

The DfE has announced six new members to the new Child Safeguarding Practice Review Panel, drawing on professional experience from the police, children's social care, education and health sectors.

The independent panel, created under the Children and Social Work Act 2017, is one of the Government's major reforms to child safeguarding and protection, and will bring together individuals who have a wide range of expertise to improve the welfare of children around the country.

The new panel members will work with the chair, Edward Timpson CBE, to consider and share lessons to improve practice from the most serious child safeguarding cases.

Innovation fund open to help children of dependent drinkers (22/05/18)

£4.5m of joint funding for up to 8 LAs, aimed at improving the support services for children of dependent drinkers and alcohol dependent parents, has been committed by the DH and Social Care and the DWP. The fund is being managed by PHE, who announced today that LAs can now bid for funding.

Alcohol can be a major factor in causing parental conflict, which can lead to a range of poor outcomes for children including damaging their education, employment and health. It's estimated there are 200,000 children living with adults who are dependent drinkers. Not only are children of parents with alcohol dependency more likely to become dependent themselves, but between 2011 and 2014 parental alcohol misuse was recorded as a factor in 37% of cases where a child was seriously hurt or killed. Similarly, a DfE census showed that in 2016 to 2017 18% of children 'in need' were affected by alcohol.

Alongside this call for bids PHE has published a toolkit to support LAs in planning services. The toolkit includes data and advice on how best to meet the needs of children growing up in these situations and those of their parents and carers. This is the first time PHE has published local prevalence data of this nature. New laws will be created to make sure that the UK is the safest place in the world to be online, Digital Secretary Matt Hancock has announced (20/05/18)

- New online safety laws to be created to make sure the UK is the safest place in the world to be online

The move is part of a series of measures included in the government's response to the Internet Safety Strategy green paper. The Government has been clear that much more needs to be done to tackle the full range of online harm.

Our consultation revealed users feel powerless to address safety issues online and that technology companies operate without sufficient oversight or transparency. 6 in 10 people said they had witnessed inappropriate or harmful content online.

The Government is already working with social media companies to protect users and while several tech giants have taken positive steps, the performance of the industry overall has been mixed.

The UK Government will therefore take the lead, working collaboratively with tech companies, children's charities and other stakeholders to develop the detail of the new legislation.

Annual Stability Index for children in care (01/06/18)

CC Anne Longfield is publishing her second Stability Index, an annual report which tracks the experiences of children in care. The Index gathers data from LAs in England to assess how frequently children in care are 'pinging' around the care system – changing home, school or social worker over the course of a year.

This year's Index shows many children in care receive stable and consistent care but reveals that thousands of children are still 'pinging' around the system, changing homes, schools or social worker. The report also shows just how disruptive changing school can be.

The research suggests that older children – especially those entering care from 12 to 15 – are most at risk of instability and may need extra support to prevent placements breaking down. It also highlights the importance of getting children in care into the best schools: children at poor-performing schools are more likely to experience a school move, and less likely to move to a better school. By comparison, those in good schools are less likely to move, and when they do it is usually to another good school.

Children in care are doing well in Wales (15/05/18)

Most children and young people in care in Wales are doing well, new research shows. The study set out to explore the placement journeys for children in care in Wales, how these compare with the outcomes aspired to in their Care Plan and the key success factors associated with positive placements.

The report found:

- Over ¾ of the whole cohort of children experienced a high level of placement stability with either no placement move (30%) or only one placement move (46%) over the 4-5 year period that the study looked at.
- 71% of the smaller sub-sample had overall positive outcomes in relation to their home environment, communication and attachments; education; physical health and the absence of offending; 19% had mixed outcomes; and 10% had overall negative outcomes;
- Whilst 78% of the whole cohort of children was officially recorded as having a primary need for care relating to abuse and neglect, the in-depth analysis found that almost all children in the sub-sample had experienced abuse and neglect before the Care Order was made.

Service helping to keep families together goes Wales-wide (29/05/18)

The Reflect programme was initially developed by Newport City Council, with the assistance of Barnardo's Cymru, to support mothers following the compulsory, permanent removal of one or more children due to child protection concerns.

In every year since 2010, Newport has seen between 11 and 16 babies removed at birth and placed for adoption when the child's mother has previously had a child removed. In one family, nine children had been removed at birth. Heads of Children's Services across Wales have established this pattern is common across the country.

Last year, the Welsh Government announced an additional £8m investment to provide further support for looked after children. £850,000 a year has been allocated to support the roll-out of the Reflect programme across Wales.

Reflect delivers intensive, one-to-one support to at-risk women in the hope that they can improve their lives, by reducing the emotional, social and financial costs of children being taken into care in the future. Those involved are offered emotional support alongside practical help including contraceptive advice and access to housing, education and employment services.

Green Paper on Child Mental Health lacks ambition (09/05/18)

The Government's proposed Green Paper on Transforming Children and Young People's Mental Health lacks ambition and will provide no help to the majority of those children who desperately need it, say the Education and Health and Social Care Committees in a joint report.

The Committees are worried that the long timeframes involved in the Government's strategy will leave hundreds of thousands of children and young people unable to benefit from the proposals. The Government is rolling out new "Trailblazer" pilot projects where mental health teams provide extra support alongside waiting time targets. SI 2018/688 - The Education (Pupil Information) (England) (Amendment) Regulations 2018 (08/06/18)

These amend the 2005 Regulations and provide that the information to be included in the head teacher's report to parents for pupils with SEN in KS2 must include the pupil's assessment in English and mathematics and remove the reporting requirement for science.

They also amend the information to be included in the CTF when a pupil in the first or second key stage has been assessed

against P Scales of attainment moves from a maintained school to another school (whether maintained or not) to include the pupil's assessment in English and mathematics.

The Regulations also remove the inclusion of the reporting requirements in science and other foundation subjects.

Commons Select Committee Report - Modernising the DBS (25/05/18)

The DBS modernisation programme is another example of a HO project marred by poor planning and contracting, delays, spiralling costs, and a failure to understand what service users want. The modernisation programme is over 4 years late and costs are expected to be £229m more than initially planned, while the new update service has seen a fraction of the demand expected by the HO in 2012.

DBS re-evaluated the programme in 2014 but has not done enough to turn the programme around.

DBS is now negotiating with its contractor to deliver the programme, including agreeing a date for when modernisation will be complete. There is a strong risk that they may run out of time before the contract ends in March 2019.

In addition, the update service has not delivered the promise of a cheaper, better safeguarding service for customers.

Instead of providing savings, DBS is charging customers £13 a year for the update service instead of the £10 expected in 2012 and is holding onto cash generated from the rest of the services it provides, building up a surplus at the expense of its customers.

The HO needs to keep a close watch over negotiations and ensure that taxpayers, who have already seen too much money wasted on the programme, do not continue to see money going down the drain.

Children in need of help and protection: call for evidence (21/05/18)

We want to understand what it is that makes the difference to the educational outcomes of Children in Need in practice, how some Children in Need can achieve better educational outcomes than others, and what works in enabling Children in Need to achieve their potential.

We need to develop a stronger evidence base, going beyond the data to look at what is happening in practice. At different stages in a child's life, or when requiring different levels of statutory social care support, children's needs will require a different response. At each of these stages, a child may work with a variety of professionals who offer support to a child and to their family, to improve a child's circumstances.

Through the call for evidence, we want to understand how the work of professionals supporting Children in Need can make a difference to educational outcomes. Specifically, we are interested in:

- how support is delivered or commissioned to help children
- how this support is measured and evaluated
- how this support influences educational outcomes

Children in Need are a legally defined group of children, assessed as needing help and protection as a result of risks to their development or health. This group includes children subject to Child in Need Plans, Child Protection plans, Looked After —

Children, young carers; and disabled children.

5th December 2018 Manchester £170 - £525 + VAT Latest government figures show that there are 72,000 children in care in England.

A recently published report surveyed 2,263 people that had been taken into LA care. The responses revealed that for 83%, being in care was a positive experience and had enhanced their wellbeing and improved their lives. However, the findings also highlighted areas that required improvements, such as communicating why the person has been taken into care, frequent changes in social workers and the feeling of not being listened to and decisions being made without consultation.

Next steps for alternative provision in England: quality, delivery and progression

This seminar will examine the next steps for alternative provision (AP) in England.

Delegates will discuss the Government's recently-published plan for reforming AP, which focuses on improving quality and meeting individual needs, developing best practice and partnerships, and expanding the number of AP free schools - and would introduce a dedicated AP Innovation Fund.

Sessions will also consider next steps for improving outcomes for children and young people when leaving AP and transition to other education settings, training, higher education and employment - looking at guidance and relationships with employers and post 16 providers.

The agenda also includes a session looking at standards, and the quality and oversight of AP in unregistered settings.

The seminar will be an opportunity to consider the findings of the Education Select Committee's AP inquiry, looking at routes in AP, the standards of teaching and outcomes for students - and follows the announcement of an independent review
