Mental Health 2018 - Delivering the Five year Forward View

19th of September 2018 London

The independent Mental Health Taskforce published its Five Year Forward View in February 2016 which set out the current state of mental health service provision in England and made recommendations in all service areas. NHS England accepted all the recommendations in the report for which it held responsibility and it was agreed with the Government that to support this transformation, mental health services will benefit from additional investment of £1bn per year by 2020/21.

In July 2016, NHS England published an Implementation Plan detailing how it will deliver the recommendations made by the Taskforce working with its partner arms-length bodies. The Plan presents the timeframes and funding for delivery of the programmes of work which will transform mental health services.

It shows how the delivery partners will work together at national and local level, and how they will be held to account for meeting the timeframes and for using the funding in the most effective way.

NHS England has established strong governance structures to oversee the work and to hold the health and care system to account for improving mental health services.

This conference is an opportunity to consider progress of the Implementation Plan and monitor progress on it's commitments to transform mental health services. This conference will allow participants to hear from senior leaders from many of the key partner organisations involved in the Five Year Forward View for Mental Health.

Next steps for alternative provision in England: quality, delivery and progression

19th October 2018 London £230 + VAT

This seminar will examine the next steps for alternative provision (AP) in England.

Delegates will discuss the Government's recently-published plan for reforming AP, which focuses on improving quality and meeting individual needs, developing best practice and partnerships, and expanding the number of AP free schools - and would introduce a dedicated AP Innovation Fund.

Sessions will also consider next steps for improving outcomes for children and young people when leaving AP and transition to other education settings, training, higher education and employment - looking at guidance and relationships with employers and post 16 providers.

The agenda also includes a session looking at standards, and the quality and oversight of AP in unregistered settings.

The seminar will be an opportunity to consider the findings of the Education Select Committee's AP inquiry, looking at routes in AP, the standards of teaching and outcomes for students - and follows the announcement of an independent review into school exclusions, which is due to report by the end of the year.

Planned sessions will also examine the impact of AP free schools, including the lessons learnt and priorities for the next wave.

Healthy child healthy future: a whole council approach to childhood obesity

Childhood obesity is one of the biggest health challenges of the 21st century. At the start of primary school, one in 10 children are obese and by the end, that has increased to one in five. If you include those who are overweight, the rates rise to a more than a fifth and a third respectively.

The government in England published its next chapter of the child obesity plan over the summer, with the bold ambition to halve child obesity by 2030.

We know that those growing up in the most deprived communities are at the greatest risk. The chances of being obese are about twice that of those who live in the least deprived areas. It is an 'obesity gap' that has been getting wider over the past decade.

We are seeing councils up and down the country trying a host of innovative approaches in a wide variety of ways, and different partners, that the sector is working with their colleagues in planning to not only restrict takeaways, but also working proactively to ensure new developments take into account health and wellbeing. Some are focussing on getting children physically active – the latest figures suggest less than one in four children are achieving the required levels.

Meanwhile, others are concentrating on food and diet. In doing so, they are forging important partnerships with early years settings, schools, community groups and local businesses.

Looked After Children: Improving Life Chances

Latest government figures show that there are 72,000 children in care in England.

A recently published report surveyed 2,263 people that had been taken into LA care. The responses revealed that for 83%, being in care was a positive experience and had enhanced their wellbeing and improved their lives. However, the findings also highlighted areas that required improvements, such as communicating why the person has been taken into care, frequent changes in social workers and the feeling of not being listened to and decisions being made without consultation.

This conference will offer delegates the opportunity to be fully briefed on the current situation within the care system and gain an update on the latest developments in terms of policy and funding.

There are 650,000 children living in "high risk" environments in the UK while 800,000 young people are suffering with some form of mental health problem.

In response, the Government has announced £17m of additional funding to improve children's services and unveiled plans to increase information sharing across safeguarding organisations.

In January 2018 the Children's Commissioner published the "Life in Likes" report, highlighting how new technology presents a new safeguarding challenge. Experts believe the anxiety and stress caused by social media use is a contributing factor to a growing mental health crisis among school children.
