#### Policy paper - Fostering better outcomes (20/07/18)

Sir Martin Narey and Mark Owers's independent review of the fostering system in England was published by the DfE on 6 February 2018. This document sets out the government's response to that report and to the Education Select Committee's inquiry into fostering.

The response sets out the steps we are taking to improve the outcomes and well-being of children in care. It is accompanied by a young people's version which describes how we are responding to their calls for improvements to fostering services.

# Plans to help children in foster care experience loving and stable homes (20/07/18)

Children and Families Minister Nadhim Zahawi announces new measures to improve foster care, as part of the government's response to two fostering reviews.

Foster families are to receive clearer advice on physical affection so that they can feel more confident to hug and comfort the children in their care, as the

Government sets out new measures to help children in foster care experience loving and stable homes.

The new plans published today focus on the experiences and outcomes for children in foster care, helping to support those who may have had a difficult start to lead fulfilling and normal lives.

Foster families will also be empowered to make more day-to-day decisions in the best interests of the children in their care, including simple but important things like being able to take children to get their haircut, allowing them to go on school trips or to be able to go over to friends' houses.

The DfE will also explore ways digital technology can enhance the foster care system and consider how it could help tackle challenges such as recruiting more families to become foster parents and have access to training and resources to support these families.

### Projects to improve education for children with additional needs

(06/08/18)

Children taught in alternative provision are set to benefit from new projects to help them fulfil their potential, including work placements, careers advice and behaviour mentoring.

School Standards Minister Nick Gibb has announced 9 innovative schemes to benefit from a £4m fund to develop new ways of improving alternative provision, to support children educated outside of

mainstream or special schools and help them succeed later in life.

Evidence shows children educated in alternative provision are less likely to achieve good GCSE grades and are less likely to be in education, employment or training post-16. The projects announced today aim to tackle these injustices by supporting children back into mainstream education when it is suitable, encouraging parents and carers to be more involved in their child's education, helping young people make good academic progress, and moving on to further education or employment.

From September the projects are set to improve outcomes through literacy and maths tutoring, summer holiday activities to support transition to further education, and the introduction of robots to enable children in hospital to participate virtually in lessons. ### Community groups provided with additional funding to tackle knife crime (02/08/18)

Today Minister for Crime, Safeguarding and Vulnerability Victoria Atkins confirmed that 67 charities across England and Wales will be provided extra funding from the Home Office's Anti-Knife Crime Community Fund.

The second round of the Community Fund opened in May 2018 and was originally set at £1m. Due to the number and quality of bids submitted, and as part of the government's commitment to early intervention and prevention to tackle serious violence, the funding has been increased to over £1.5m.

These successful bids, which were selected due to their commitment to educating young people about the dangers of carrying weapons, are set to receive up to £30,000 each.

#### **Sport a pillar of youth rehabilitation** (11/08/18)

Justice Minister Edward Argar has published an independent review of sport and physical education in the youth justice system.

- leading academic highlights the power of sport in transforming lives of young offenders
- community partnerships to support the development of sport and physical activity in custody
- offenders engaging in structured programmes learn self-discipline, team work and leadership and communication skills – all crucial for a successful life on the outside

The review, authored by Professor Rosie Meek, was commissioned to identify best practice across the estate and highlights the vital role that sport can play in rehabilitation and reducing reoffending.

In addition to Professor Meek's review, the MoJ has published its response which highlights the steps that will be taken to boost sporting provision in prison.

Many of the sporting programmes currently delivered across the youth estate help offenders to get vocational qualifications and provide them with tangible employment prospects on release.

The review highlights how engaging in structured programmes can help to teach offenders self-discipline, team

leadership - crucial skills for a successful and crime-free life in the community.

Team sport was shown to improve mental and physical health, helping young people with often complex behavioural issues to change their attitudes and lifestyles.

# Home Secretary launches and doubles the early intervention youth fund (30/07/18)

More projects to steer young people away from serious violence will be supported by the government after the Home Secretary announced the doubling of the early intervention youth fund.

The scheme, which opens for bids today, is a key commitment in the Serious Violence Strategy, and will allow communities to intervene early in the lives of more vulnerable young people.

The government will double the funding, which was originally set at £11m. Now £22m of Home Office money will be made available to support vital early intervention work in England and Wales over the next 2 years.

Police and Crime Commissioners who work in partnership with Community Safety Partnerships or the equivalent can bid for funding to deliver projects which steer young people away from violent crime.

It is a prime example of the public health - or multiple strand - approach set out in the strategy, which is aimed at

addressing the causes of violence. Robust policing remains very important, but the Home Office is also working in partnership with a range of key sectors, such as education, local government, health and social services, to tackle serious violence.

#### **Independent review of the Modern Slavery Act 2015** (30/07/18)

The HO announces plans to launch an independent review of the Modern Slavery Act 2015. It comes as new HO research reveals the devastating impact of modern slavery.

Each instance of the crime is estimated to cost around £330,000, including the cost of support, lost earnings and law enforcement but most significantly the physical and emotional harms suffered by individuals, who are often exploited over months and sometimes years. This places each modern slavery crime as second only to homicide in terms of harm to its victims and society.

The review aims to strengthen the UK's ongoing response and accelerate progress from Government and businesses in eradicating modern slavery.

#### Children affected by domestic abuse to benefit from £8m fund (21/07/18)

The fund gives charities, LAs and other organisations the chance to bid for money for projects designed to intervene early to help children who have been directly or indirectly affected by domestic abuse.

Domestic abuse ruins the lives of its victims with more than 2m people subjected to this terrible crime each year.

However, NSPCC statistics show that as many as 1 in 5 children in the UK are also witness to or exposed to this horrible crime during childhood. Some 25% of girls and 18% of boys aged 13 to 17 have reported having experienced some form of physical violence from an intimate partner.

Those children affected by domestic abuse in their early years are 4 times more likely to go on and experience or perpetrate domestic abuse later in life. Further studies have also concluded that children affected by domestic abuse are at greater risk of falling into substance abuse, juvenile pregnancy and criminal behaviour than those raised in homes without violence.

#### **Measles outbreaks across England** (06/08/18)

Public Health England is advising the public to ensure they have had 2 doses of MMR vaccine after outbreaks of measles are confirmed across England.

Between 1 January 2018 and 6 August 2018 there have been 807 laboratory confirmed measles cases in England. Cases were reported in most areas with London (281), the South-East (166), South-West (139), West Midlands (84) and Yorkshire and Humberside (75) reporting the most cases (based on provisional figures).

The increase in measles circulation is mainly associated with travel to and from Europe where there are large ongoing measles outbreaks.

Young people and adults aged 15 and over who missed out on MMR vaccine when they were younger and some under-vaccinated communities have been particularly affected.

Measles is a highly infectious viral illness that can sometimes lead to serious complications and can be fatal in very rare cases.

Anyone who has not received 2 doses of MMR vaccine is at risk, but young people in environments with close mixing such as festivals are more at risk, as well as unvaccinated people travelling to Romania and Italy, where there are currently large outbreaks. Anyone planning to travel to Europe

should check NaTHNaC travel health advice.

PHE local health protection teams are working closely with the NHS and local authorities to raise awareness with health professionals and local communities.

The MMR vaccine is available to all adults and children who are not up to date with their two doses.

Anyone who is not sure if they are fully vaccinated should check with their GP practice who can advise them.

# Select Committee - Forgotten children: alternative provision and the scandal of ever increasing exclusions (25/07/18)

Alternative provision is a broad term and imperfectly describes a wide variety of types of school or educational settings. Our inquiry scope included PRUs; alternative provision academies and free schools; hospital schools; and alternative provision delivered by charities and other organisations as well as independent or un-registered schools.

# Online abuse and the experience of disabled people: draft recommendations for consultation (03/8/18)

Our inquiry into online abuse and the experience of disabled people was prompted by a petition by Katie Price, signed by more than 200,000 people. Her petition calls for a specific criminal offence to cover online abuse and a register of offenders. It talks about online abuse directed at people from all backgrounds, but also highlights the shocking abuse directed at her disabled son, Harvey.

In our inquiry, we have come across some examples of good practice in attempting to meet the needs of disabled people and their families. More often, though, we found that disabled people were not being consulted or even considered. This was particularly apparent in the very disappointing evidence we received from the Department for Digital, Culture, Media and Sport and heard from social media companies. We do not intend to make the mistake of ignoring disabled people here.

We release our draft recommendations as a special report to allow us to consult disabled people and their families. These draft recommendations come from our conversations with and evidence from disabled people, the police, social media companies and legal experts. We will consult online and offline in August and September 2018 to ensure that our final

#### The Independent Inquiry into CSA

The report highlights the evidence heard by the Inquiry of appalling sexual abuse inflicted over decades on children as young as seven at Ampleforth and 11 at Downside.

It also concludes that there was a culture of acceptance of abusive behaviour and the prioritisation of monks and their reputations over the protection of children.

Three in four young carers feel lonely in the summer holidays (02/08/18) Our research, developed with the Carers Trust, shows that 72% of young carers feel lonely during the summer holidays.

We surveyed young carers under 18, which found nearly half spend more than four hours a day during the summer caring for a relative – the equivalent of losing an entire week of their holidays. And while many families are enjoying quality time together on a trip away, thousands of young carers are stuck at home – shockingly, one in five said they have never been on a summer holiday with their family.

With so much time taken up caring for loved ones and less time to relax, more than two thirds feel more stressed or worried during the holidays; while more than half worry about talking about what they did in the summer break when they go back to school.

There are an estimated 700,000 children and young people across the UK caring for a family member with a disability, illness or mental health problem - some as young as five years old.
