26 years ago a 14 year old school boy was gunned down on the streets of Moss Side, Manchester. John 'Benji' Stanley's death heralded the early beginnings of the gang culture, its cause, effect and impact on the many lives that have been lost over the past quarter of a century and the climate of fear and despair that continues to blight our communities.

The Government is determined to do all it can to break the deadly cycle of violence that devastates the lives of individuals, families and communities. The 'Serious Violence Strategy' launched on 9th April 2018 sets out how we will respond to serious violence. Funding of £40 million has been made to boost local 'open access' youth provision in six targeted disadvantaged areas in England.

This conference will look at the cities affected, lessons learned, what works, what doesn't work and more importantly what we need to do in order to prevent, intervene and rehabilitate disaffection, disadvantage and disillusionment that can lead to anti-social behaviour, gang related violence and extremism.

## **Keeping Children and Young People Safe Online: Preventing Threats, Ensuring Protection** 22<sup>nd</sup> May 2019 London £299 - £550 + VAT

Whilst the Internet is a great resource, there are many risks that can be encountered by children and young people. Using the internet as a learning tool can be extremely beneficial and enhance

learning in many ways, however it is important to Incorporate internet safety themes across the curriculum. Almost 1 in 4 of 8-11-year olds and 3 in 4 of 12-15 year-olds has a social media profile (Ofcom 2017). 1 in 4 children have experienced something upsetting on a social networking site and around 1 in 8 young people have been bullied on social media.

Since 2014 online safety has been part of the National Curriculum and it is inspected by Ofsted. The DfE's statutory guidance 'Keeping Children Safe in Education', 2015, updated in September 2018, obliges schools and colleges in England to "ensure appropriate filters and appropriate monitoring systems are in place. Children should not be able to access harmful or inappropriate material from the school or colleges IT system" however, schools will need to "be careful that "over blocking" does not lead to unreasonable restrictions as to what children can be taught with regards to online teaching and safeguarding." Digital Secretary Matt Hancock announced in May 2018 that new laws will be created to make sure that the UK is the safest place in the world to be online following the Internet Safety Strategy consultation.

### The Future of Children's Services Inspections

 $27^{\text{th}}$  June 2019 London £299 - £550 + VAT

In January 2018 Ofsted introduced the new Inspections of LA Children's Services (ILACS) framework. It looks at how well LAs are supporting and protecting vulnerable children in their area. The new approach allows Ofsted to prioritise inspection where it is most needed and more proportionate, risk-based and flexible than before. The new arrangements consist of short inspections, standard inspections, monitoring and focused visits. LAs are also asked to annually evaluate the quality and impact of their social work practice, as well as having a formal yearly conversation with Ofsted about their performance.

LAs are facing a dramatic rise in demand for children's services, with the number of child protection enquiries having increased 158% in 10 years. Over the same period, there has been an increase of the number of children on child protection plans of more than 25,000 and the biggest annual rise of children in care in 8 years in 2017/18, with an average of 88 children coming into care every day. Whilst the demand has risen, funding has been cut, with councils facing a £3.1b funding gap for children's services by 2025. In 2017/18, councils across England were forced to spend £816 more on children's social care than they had budgeted for.

This conference examines the progress of the new inspection framework in its first year. Featuring a wide range of case studies by LA children's services who have achieved significant improvements in their Ofsted ratings, delivered innovative solutions to service delivery and efficiency savings while facing the challenges of increased demand and budget cuts. # The National NHS Safeguarding Event 2019: A Multi-Agency Approach to protecting the lives of children and adults

ecent figures demonstrate an upward trend in safeguarding incidents, with the DfE's latest statistics showing the number of children subject to a child protection plan increasing at a rate of 5.3% per annum. The NSPCC's annual How safe are our children? report also charts increases in

recorded child cruelty and neglect offences, as well as an increase in the number of recorded sexual offences against children.

At the same time, NHS Digital's annual Safeguarding Adults 2018 report shows an 8.2% increase in concerns of abuse being raised, with older people much more likely to be the subject of safeguarding enquiries. The most common location of risk was the person's own home, meaning that identification could have come through a number of key services including health, social care and police.

Work to address these trends is being undertaken right across government and the public sector, with key legislation and reforms including the Mental Capacity (Amendment) Bill and Liberty Protection Safeguards, the Children and Social Work Act 2017, the Working Together to Safeguard Children reforms, and the Domestic Abuse Bill 2018. These multi-agency reforms are resulting in some of the biggest changes to both child and adult safeguarding seen in the last 40 years, and the NHS has an imperative role to play in delivering them.

This forum provides an opportunity to hear the latest policy updates and initiatives from senior policymakers designed to offer a clear understanding of key legislation and reforms and how they underpin the NHS' safeguarding priorities for 2019 and beyond. In particular, it will focus on the need for different agencies to collaborate, highlighting how relationships between health and other services should operate — at both strategic and operational levels — to safeguard children, young people and adults at risk of harm or abuse.
