## New programme to protect children at risk of exploitation (09/05/18)

Children most at risk of being targeted by gangs or violent crime will benefit from better support from specialists across education, health, social care, police and the voluntary sector in a programme launched by Education Secretary Damian Hinds.

The new 'Tackling Child Exploitation Support Programme' is designed to improve how different local areas respond to child exploitation – such as gang, 'county lines' drug dealing, online grooming, sexual exploitation, trafficking or modern slavery – backed by £2. It will help equip professionals involved in the protection of young people to identify those most at risk from dangers in their communities and online.

### **Child exploitation disruption toolkit** (15/04/19)

The toolkit is primarily aimed at frontline staff, including law enforcement, social care, education, housing and the voluntary sector, working to safeguard children and young people under the age of 18 from sexual and criminal exploitation.

Additionally, it is intended to help all safeguarding partners to understand and access existing legislative opportunities at their disposal and to target specific risks

and threats.

The use of existing legislative powers, such as orders and injunctions, are an essential part of the safeguarding process.

The toolkit aims to set out many of the tools useful for police and other safeguarding professionals to disrupt the sexual and criminal exploitation of children and young people, break the cycle of abuse and send a signal to perpetrators about the consequences of their actions.

The toolkit incorporates relevant legislation to address:

- abduction and trafficking
- sexual offences
- victim care
- unusual or harmful behaviour
- locations of specific concern

In addition, the toolkit includes best practice in information sharing and multiagency working as well as intelligence and evidence gathering.

#### Home Secretary to take action against violent content online (24/04/19)

Chairing the latest Serious Violence Taskforce, the Home Secretary heard what steps social media companies have taken to tackle violent content online.

The Home Secretary also confirmed the new £1.38m government funded social media hub will be fully operational at the end of May. The new 17-strong team of police staff and officers will be tasked with disrupting and removing overt and covert gang-related online content.

At the Taskforce, senior leaders from Google and Facebook updated members on the action they are taking to protect vulnerable users from harmful content, including videos promoting violence.

It comes after the government launched the Online Harms White Paper which proposes a new statutory duty of care on social media companies and an independent regulator appointed to enforce the new standards.

As of today 'upskirting' offenders can be arrested and sent to prison as a new law banning the invasive practice comes into force across England and Wales.

The criminal offence of 'upskirting' was created under the Voyeurism Act when it received Royal Assent in February. Police and prosecutors have now updated their guidance to ensure the law is properly enforced – with offenders facing up to 2 years in jail and being placed on the sex offenders register.

Today marks the culmination of tireless campaigning from Gina Martin and other victims, MPs and charities who worked closely with Ministers to create the new law and protect more victims.

#### Government unveils new support for survivors of domestic abuse (13/05/19)

Thousands of survivors fleeing abusive and violent relationships will receive greater protection thanks to a new package of support, confirmed by the Prime Minister.

For the first time ever, councils across the country will be legally required to provide vital life-saving support in secure accommodation for survivors of domestic abuse and their children – ensuring need in their local area is met.

Domestic abuse is a devastating crime which shatters the lives of over 2 million survivors and their families every year.

While many LAs are already providing tailored support to those fleeing violent relationships, more needs to be done to end the variation across the country in support and ensure a consistent approach across the country so all families are able to recover and overcome their experiences.

LAs will also be required to work together with neighbouring councils to ensure domestic abuse services reflects the needs of local people – including targeted, specialist support for BAME, LGBT and Gypsy, Roma and Traveller survivors.

Today's consultation complements wider work across government, including a landmark Domestic Abuse Bill which will introduce the first ever statutory government definition of domestic abuse to specifically include economic abuse and controlling and manipulative nonphysical abuse.

## **Schools backed to tackle bad behaviour** (04/05/19)

More than 500 schools will be part of a pioneering scheme to tackle bad behaviour in schools, backed by £10m investment.

Behaviour expert and former teacher Tom Bennett, who led a national review to identify the best ways of dealing with disruptive behaviour in schools, will lead the programme, where a network of expert schools will be identified to help teachers and school leaders in need of support.

More than 82% of parents consider good discipline in the class a key factor when choosing a school for their child, according to research. However, over a third of schools are not currently judged as having good enough behaviour by Ofsted. With low level disruption costing individual pupils up to 38 days a year of learning and dealing with poor behaviour cited as a key reason for teachers leaving the profession, the Government is determined to take action.

The scheme follows a successful £2m programme in the summer of 2018, which saw charities and community groups provide meals and activities such as football, play sessions and cooking classes for more than 18,000 children across the country.

To build on that, ministers have more than quadrupled the funding ahead of summer 2019 so that even more disadvantaged children can benefit.

## **Edward Timpson publishes exclusions** review (07/05/19)

Schools will be made accountable for the pupils they exclude and there will be a clampdown on off-rolling, as part of Government measures taken in response to the Timpson Review of exclusions.

The review makes 30 recommendations to Government as it highlights variation in exclusions practice across different schools, local authorities and certain groups of children. The report concludes that while there is no optimal number of exclusions, there needs to be action to ensure permanent exclusions are only used as a last resort, where nothing else will do.

Analysis shows 85% of all mainstream

schools not expelling a single child in 2016/17, but 0.2% of schools having expelled more than ten pupils in the same year.

Vulnerable groups of children are more likely to be excluded, with 78% of permanent exclusions issued to children who had special educational needs (SEN), or classified as in need or eligible for free school meals. Certain ethnic groups, including Bangladeshi and Indian pupils, have lower rates of exclusion than White British pupils, with the analysis also finding some ethnic groups, such as Black Caribbean and Mixed White and Black Caribbean pupils, experiencing higher rates, after controlling for other factors. https://www.gov.uk/government/news/ed ward-timpson-publishes-landmarkexclusions-review https://www.gov.uk/government/consultat ions/school-exclusions-review-call-forevidence

# Investigation into child protection in religious organisations and settings (02/05/19)

The IICSA has announced a new investigation into child protection in religious organisations and settings. The thematic investigation will review the current child protection policies, practices and procedures in religious institutions in England and Wales.

Organisations falling under the remit of this investigation will include non - conformist Christian denominations, the Jehovah's Witnesses, Baptists, Methodists, Islam, Judaism, Sikhism, Hinduism and Buddhism. This investigation is separate from our investigations into the Anglican and Roman Catholic churches.

Religious settings such as mosques, synagogues, churches and temples are in scope. Places of faith tuition such as Muslim madrassahs and Christian Sunday schools and places where children and young people gather in connection with their religious beliefs, including youth groups and camps will also be investigated by the Inquiry.

11% of survivors of CSA who shared their accounts with the Inquiry's Truth Project reported sexual abuse in a religious institution. Of this group, 24% said they were abused in institutions in scope of this new investigation, including Jehovah's Witnesses, Baptists, Methodists, Judaism and Islam. Not all participants provided details about the religious denomination of the institution or perpetrator.

Representatives of Facebook, Google, Apple and Microsoft are among those due to give evidence, as well as the police and government.

# Making substance misuse and mental health support more inclusive (03/05/19)

How a service for young people in North Yorkshire works with other agencies to focus on all their emotional wellbeing, substance misuse and mental health needs.

Compass REACH is a specialist service that works with children and young people aged 9 to 19 (and up to 25 for those with SEND) who have moderate or high levels of need related to their drug or alcohol misuse, or require sexual health interventions.

It also works with children and young people who could benefit from receiving early help and prevention work to support their emotional wellbeing and mental health needs. The young people who access the service can receive interventions just for substance misuse or emotional wellbeing difficulties, or for a combination of the two.

North Yorkshire County Council commissioners set up Compass REACH (as North Yorkshire Risk Taking Behaviour Service) in September 2012 to provide consistent services across the county for young people.

The service began as a substance misuse and sexual health service, based on a nurse-led staffing model which helped young people to access psychosocial support alongside clinical interventions for sexual health (such as emergency hormonal contraception) from the same practitioner.

In 2015, North Yorkshire CC recommissioned the school nursing service and the specialist substance misuse service under the umbrella of the healthy child service. They extended the Compass REACH service to include early help for emotional wellbeing and mental health issues. Since then, Compass REACH has provided specialist substance misuse interventions, and early help and prevention support for sexual health, emotional wellbeing and mental health issues.

## New research finds missing children are being let down (01/05/19)

New research by The Children's Society, found on average just 50%[1] of missing episodes resulted in return home interviews taking place, despite it being a statutory requirement on local authorities to offer them each time a child goes missing.

A Return Home Interview (RHI) is an in-depth discussion between an independent trained professional and the child or young person. It aims to find out what happened to them during their missing episode – so who they met and where they stayed and any risks they may have been exposed to. In some areas as few as one in five missing incidents resulted in interviews whilst in others areas nearly all of them did.

The research, which was commissioned by the National Police Chiefs Council Lead for Missing People with funding from the Home Office, found many councils were unable to provide any data on the number of children going missing in their area, how many return home interviews were offered and carried out, or what help was offered to children as a result of RHIs. https://www.childrenssociety.org.uk/news-and-blogs/press-releases/new-research-finds-missing-children-are-

#### Knife crime briefing (27/04/19)

This briefing may usefully inform decisions about approaches to tackling knife crime following the increasing number of these types of offences over the last few months.

All police forces in England and Wales have initiatives to tackle knife crime and this briefing can be used to:

- Make informed decisions on where resources or funding may be of most benefit to tackle the issue
- Evaluate existing activity against the briefing to understand what approach has the greatest potential to reduce crime
- Develop broad multi-agency strategies aimed at prevention and early intervention.

#### It concludes:

Knife crime perpetrators and victims are most likely to be males in late adolescence. Risk factors for serious violence and weapon carrying include adverse childhood experiences and poor educational attainment. Ethnicity has been found to have no significant effect on weapon carrying in the UK.

The most successful approaches to reducing violence include well-implemented problem-solving and focused deterrence strategies, such as the US-based 'pulling levers', which aim to address the root causes of violence.

Public health approaches, involving multiple agencies to develop a range of interventions, including prevention work for at-risk groups, as well as law enforcement activity directed at offenders, have been shown to have a positive impact.

#### The National Combating Gangs, Violence and Weapon Crime Conference 2019

3<sup>rd</sup> December 2019 London £299 - £550 + VAT

Reports of violence, stabbings and murders have hit the headlines over the past 12 months with daily occurrences in London. But how widespread is violent crime, why is it growing and who are the victims?

The vast majority of people will not be a victim of violent crime. In England and Wales, 4 in 5 people did not experience crime in 2017 and overall crime has been steadily decreasing since 1995. However, high-harm incidents, including offences involving knives and firearms, are on the rise. In the year ending in March 2018 police recorded a 16% increase in offences involving a knife or a sharp instrument, totalling over 40,000 offences, the highest number since 2011.

While the rise of gun crime has slowed, with a 2% increase in the same period, serious firearm offences increased significantly, and the number of homicides recorded by the police showed a fourth consecutive rise, increasing by 12%. While these crimes remain rare, they attract a lot of media attention.

Dramatic increases in knife crime in the home counties, rising by an average of 44.8% over the past 8 years, suggest

that county lines drug gangs are spreading violent crime beyond London. There has also been an increase in under-16s involved in serious incidents, with figures of under-16s treated in hospital for stab wounds doubling in the last 5 years. Meanwhile, although gangs remain a prominent proportion of violent crime, police figures suggest the rate of gang-related violent crime is decreasing while overall violent crime rises.

The Government is determined to do all it can to break the deadly cycle of violence that devastates the lives of individuals, families and communities. The 'Serious Violence Strategy' (April 2018) sets out how we will respond to serious violence. Funding of £40m has been made to boost local 'open access' youth provision in 6 targeted disadvantaged areas in England, followed by a further £9.8m in February 2019.

This conference brings together the key stakeholders involved in tackling gang, violence and weapon crime in the UK. We will be looking at tackling county lines and misuse of drugs, early intervention and prevention, supporting communities and partnerships, and an effective law enforcement and criminal justice response.
