Breast-ironing recognised as child cruelty and assault by CPS (19/07/19) Breast-ironing should be prosecuted as a form of child abuse, the CPS says in new guidance.

The harmful procedure – which involves flattening a girl's chest with a hot stone or other objects to delay breast growth – is often performed by family members to prevent unwanted sexual attention.

Charities have estimated 1,000 girls in the UK have been affected by the practice, which doctors say can cause breast cancer, scarring, infections, breastfeeding problems, and psychological trauma.

Now CPS legal guidance makes clear to police and prosecutors that breast-ironing is a crime that can be caught under existing law, even if it is said that the victim has consented.

The offences to be considered by prosecutors include child cruelty and causing or allowing a child to suffer serious harm. Both crimes are punishable by up to ten years in prison. Inquiry publishes report into Nottinghamshire Councils (31/07/19)

The Inquiry has published its report on the response to allegations of sexual abuse of children in the care of Nottinghamshire Councils.

The report found some 350 individuals reported being sexually abused whilst in the care of the Councils from the 1960s onwards. The true number is likely to be considerably higher.

It concludes that the sexual abuse of children was widespread in both residential and foster care during the 1970s, 1980s and 1990s. This included repeated rapes, sexual assaults and physical abuse.

Children's Commissioner's 2019 Stability Index (01/08/19)

This index is an annual measure of the stability of the lives of children in care in England. The Index was launched in 2017 and shines a light on the number of times children in care move home placement, school or social worker. For the first time, the Index publishes stability figures for each council.

This year's index shows how the profile and needs of children in care has changed over the last five years, driven by a growing share of older children and teenage care entrants who have more complex needs and potentially more expensive living arrangements. They are six times more likely than children under 13 to be living in residential or secure children's homes, and nearly half are living in privately-run accommodation.

It shows how the number of teenagers (aged 13 or over) in care rose by 21% between 2012/13 and 2017/18, while the number of 0-5 year olds fell by 15%, and how there has been a large increase in the number of over 16s entering care during the year. This number grew by 25% between 2013/14 and 2017/18 – much higher than for any other age group. As a result 23% of children in care are now over 16. Inspecting self-evaluation: a new approach (July 2019)

During the academic year 2019-2020 ESTYN will be piloting a new approach to self-evaluation in all maintained schools and PRUs.

From September, instead of requesting the self-evaluation report prior to inspection, there will be a professional discussion with the headteacher and nominee around the school's improvement journey.

About the changes

- As we have been developing the National Resource for School Improvement (previously the self-evaluation toolkit) it's become clear that some schools feel that they need to produce a self-evaluation report specifically for inspection.
- This approach can be time consuming and does not always identify or focus on the schools main strengths and priorities for improvement. Often these reports are prepared by senior leaders and not by the whole staff, and present the school in too positive a light, avoiding references to shortcomings that may be difficult to address.
- Focusing on professional dialogue, rather than documentation, emphasises that self-evaluation should inform and support school improvement. It is also good practice for schools to bring together findings from their self-

- evaluation processes to inform their own key stakeholders.
- This pilot will help school leaders to focus on doing what's right for their school as opposed to generating a selfevaluation report for inspection only.

During inspection, we will continue to evaluate a school's approach to evaluation and improvement. At the end of the pilot, we will carry out an evaluation to inform the development of new inspection arrangements for September 2021.

Guidance on home education in Wales published for consultation (29/07/19)

The Welsh Government has launched a consultation on new guidance for home education in Wales.

The draft statutory guidance sets out what local authorities need to do to identify children not being taught at school and provides advice on how to assess the suitability of the education those children receive.

The guidance states that children should be seen as part of the assessment of suitability of education once a year, unless there are other issues that warrant more frequent meetings. The guidance also clarifies the support local authorities should make available to home educators in their area.

A handbook has also been developed with advice and support for people currently providing or considering home education for their children. The guidance also aims to ensure the support for home educators is consistent across Wales

The Welsh Government plans to consult later this year on regulations to require local authorities to establish a database to help them identify children who are not registered at a school, or are not on an education otherwise than at school (EOTAS) register, and then to determine whether the children are receiving a suitable education. https://gov.wales/guidance-homeeducation-wales-published-consultation See consultations

New Action Plan on tackling child sexual abuse launched (15/07/19) A new National Action Plan on tackling

child sexual abuse has been published by the Welsh Government.

The plan sets out a new legal framework to strengthen safeguarding arrangements so that people at risk can be protected more effectively and is a part of the Social Services and Wellbeing (Wales) Act 2014.

The action plan was formed by considering evidence from children themselves and from adult survivors. Cross Party Group discussions on Preventing Child Sexual Abuse and evidence from the Independent Inquiry A into Child Sexual Abuse (IICSA).

The main aim of the plan is raise public awareness - getting the right information to children about speaking out and to prepare adults in their lives on being ready to listen. This will help to prevent abuse and protect children.

The plan outlines further training for practitioners to equip them with the relevant skills.

Assessing risk of harm to children and parents in private law children cases (19/07/19)

The overarching aim of the call for evidence is to better understand how effectively the family courts respond to allegations of domestic abuse and other serious offences in private law children cases, having regard to both the process and outcomes for the parties and the children.

The panel would like to hear from people who have direct experience as parties in private law children cases, as well as from those who provide support services to parents involved in such cases, and from professionals who practise such cases.

Home to school travel and transport: statutory guidance (19/07/19)

The Department for Education is consulting on revised statutory guidance for local authorities on home to school travel and transport for children of compulsory school age (5-16). The guidance was last updated in 2014. There have been no changes to the law.

The revised guidance seeks to clarify local authorities' statutory duties in relation to home to school travel and transport policy, in response to feedback from local authorities and other interested parties.

The policy for transport to post-16 education and training is different from that of children of compulsory school age, and as such is not included within this consultation.

Offensive Weapons Act 2019: draft statutory guidance (15/08/19)

The statutory guidance sets out how the legislation should be implemented and applied, the obligations imposed under the act, and what factors should be taken into account when making decisions on how to proceed with individual cases of the possession, sale and delivery of knives, corrosives and offensive weapons, and the use of these to threaten others.

The guidance is primarily for the police, retailers and trading standards. However, it will also be of interest to the Crown Prosecution Service (CPS), Her Majesty's Courts and Tribunal Service, manufacturers and suppliers of bladed articles, bladed products and corrosives, and members of the public.

The Offensive Weapons Act, which received Royal Assent on 16 May 2019, requires the Secretary of State to produce statutory guidance which covers the implementation of certain measures within the act in England and Wales. It also covers the implementation of sections 1 to 4 of the act, in respect of the sale and delivery of corrosive products, in Scotland.

The Offensive Weapons Act 2019 introduces KCPOs. These new preventative civil Orders will be an additional tool that the police will be able to use to work with young people and adults to encourage them to help steer them away from knife crime and serious violence.

KCPOs will help to divert those who may be carrying knives, or who are at greatest risk of being drawn into serious violence, away from being involved in knife crime. They will also help to prevent those who have been involved in knife crime from further offending when used following a conviction.

The guidance is intended to be used by the police and CPS but will also be of interest to the judiciary and groups that represent young people and adults within the criminal justice system.

Improving Infant Health And Wellbeing Outcomes

4th December 2019 London £299 - £550 + VAT While children's services in the UK have steadily improved over the last decade, many health and social concerns remain.

In February 2019, The Health and Social Care Select Committee published their *First 1000 Days of Life* report, examining the effect of socio-economic inequalities, children's services provision and quality of care on children's outcomes. The committee found that stresses against the ability of parents to provide a secure, healthy, nurturing environment during the early years of a child's life, often caused by poverty and deprivation, adversely affect outcomes and recommended the implementation of a national strategy to tackle this.

Following this inquiry, the Government launched the *Advancing Our Health: Prevention in the 2020s* consultation document, which sets out the Government's vision for improving provision to parents and young children. Additionally, the DWP continue to work to help workless families, a key target group for improved services and support.

These Government publications have increasingly called for an integrated approach to children's services, urging LAs, NHS Trusts, housing associations, and community organisations to work together, share information and offer joined-up services to families with young children.
