Victims and survivors tell Inquiry that physical and sexual abuse was endemic in children's homes and residential care (07/11/19)

New research from the IICSA found that 39% of children sexually abused in residential care also experienced physical abuse - and a fear of retribution stopped many victims from speaking out.

Based on the accounts of almost 200 victims and survivors who came forward to the Truth Project, the report analyses experiences of abuse in establishments such as children's homes, secure children's homes and accommodation for care leavers under 18.

Physical and emotional abuse were rife in residential care homes. Nearly 40% of survivors reported physical abuse including being punched, hit with objects and forced to fight each other, even to the point of being hospitalised. And almost one fifth described bullying, where they were called names, shouted at and threatened. 19% did not report the abuse at the time due to fear of retribution, or concerns they would get into trouble (14%).

Inquiry announces final investigation into Effective Leadership of Child Protection (01/11/19)

The IICSA has announced a new

investigation into Effective Leadership of Child Protection. The investigation will focus on practical experience of leadership and management.

In this investigation, the Inquiry will build on its findings on leadership in the interim and investigation reports and consider further evidence on issues including:

- Ensuring organisations are safe, and effective at being safe
- Achieving openness, transparency and good communication
- Ensuring good communication, escalation of issues and concerns with clear lines of accountability, and good leadership in scenarios where there is no direct line management structure
- Using management and audit information to understand the institution, its systems and its performance, so that systemic warning signs can be identified early
- Responding appropriately to internal and external pressure, for example from politicians, community leaders, parents, funders and other key stakeholders so that child welfare and protection is prioritised
- Responding to the evidence of "whistleblowers" and recommendations from inspectorates, Serious Case Reviews and similar reports
- Learning from past institutional failures, including adverse events, including embedding a 'learning' not a 'blaming' culture

Given its thematic nature, this investigation will not focus on any individual case studies or particular institution. Instead it will consider evidence on the institutional leadership themes set out above from a range of sectors in England and Wales, not necessarily limited to those with responsibility for children.

The Inquiry will have regard to the evidence already obtained about these issues in other investigations and will not seek to duplicate evidence already obtained.

These are the sixth commencement regulations made under the Children and Social Work Act 2017 (c. 16) ("the Act"). S10, Schedule 1, and Part 3 of the Act came into force when the Act was passed by virtue of S70 of the Act.

Regulation 2 brings into force on 02/12/19 the remaining provisions of Part 2 of the Act, relating to transfer of the regulation of social workers in England from the Health and Care Professions Council to Social Work England.

Regulation 3 is a saving provision in connection with the coming into force of section 39(1) of the Act.

In October 2015, the Government published its Counter-Extremism strategy which set out a programme of work that focused on the non-violent harms of extremism. The government's counter-terrorism programme has a specific focus on "prevent" which aims to anticipate and stop attacks by supporting vulnerable communities; improving the resilience of LAs; and preventing radicalisation.

The Government is spending over £2b each year to combat terrorism and radicalisation. It is working with LAs and educational institutions to develop a community lead approach and with schools and universities to safeguard young people from the dangers of extremism. It is also involving the NHS and the police to deliver a multi-agency approach to combat radicalisation.

The Prevent Duty is intended to help schools and childcare providers think about what they can do to protect children from the risk of radicalisation and suggests how they can access support to do this. Significant research has

highlighted a plethora of signs that we can use to spot students vulnerable to radicalisation. The digital world and social media can also be better harnessed to both prevent and deter young people from being radicalised.

This second annual conference offers delegates the perfect opportunity to investigate the best ways of tackling extremism in education throughout the UK.

Bringing together key organisations we will examine updates of the Prevent duty policy and what the next steps are to tackle extremism in education. We will have best practice case-studies from schools, universities and LAs on the best approach to community cohesion and what we as a whole society are doing to tackle our biggest challenge – terrorism and extremism in education.

Delivering effective Youth Services and Support 2020

The DfE has estimated that youth services have been cut by £880m since 2010. These cuts have led to youth services campaigners highlighting the connection between a decline in youth services and rising knife crime among young people.

In September 2019, the Government announced a £500m youth investment fund to help build new youth centres, refurbish youth facilities and provide youth services in hard to reach areas.

The Government is also strengthening the workforce in the youth sector through new bursaries for youth work qualifications and a review of the youth work curriculum.

Meanwhile, the National Citizen Service continues to grow and expand, having engaged half a million participants and the National Citizen Service Trust gaining Royal Charter body status in 2018.

This renewed focus on the youth sector has the potential to reinvigorate youth services for the future.

Delivering effective youth services for vulnerable youth in need of support through partnerships, effective commissioning, targeted support and safeguarding, will be key to building strong communities, reducing crime and boosting employment.
